EMISSION CONSENT ORDER

With reference to the application no. 353414 dated 22.04.2016 of M/s Sangam Mediserve Pvt. Ltd under section 21 of the Air (Prevention & Control of Pollution) Act, 1981, he/they is/are granted consent to operate his/their Common Bio-medical Waste Treatment Facility at Indira Gandhi Institute of Medical Sciences campus, Sheikhpura, Patna-800014 for a period of five years from the date of issue or till the validity of agreement with IGIMS, Patna whichever is earlier with the following conditions: -

- That, he/they shall not make any alteration, addition, deletion or modification in the plant without the prior clearance from the Board and shall also abide by the obligations under sections 22,23 and 31A of the Air (Prevention & Control of Pollution) Act, 1981 and further shall extend co-operation to the Board in performing its functions entrusted under sections 24,25 and 26 of the Act;
- That, he /they shall comply with the requirements of rule 14 of the Environment (Protection) Rules, 1986; rules 4,5,7,9,10 and 11 of the Hazardous Wastes (Management and Handling), Rules 1989; rules 4,5,7,8,10,11,12,13,15,17 and 18 of the Manufacture, Storage and Import of Hazardous Chemical Rules, 1989; and the provisions of the Public Liability Insurance Act, 1991, whichever is applicable;
- That, he/they shall monitor stack emission of the Incinerator. Stack emission monitoring report should be submitted to the Board every six months and shall maintain its quality in conformity with Board's standards and shall produce its proof, as and when asked for;
- That, he/they shall submit application for consent again 30 days before the expiration of the period of consent;
- That, the D.G set should be provided with an integral acoustic enclosure and the maximum permissible sound pressure level for new D.G set shall be 75dB(A) at 1 meter from the enclosure surface;
- That, the minimum height of stack for exhaust emission to be provided with D.G set shall be 1.0 meter more than the height of the building where it is installed;
- 7 That, the unit shall ensure regular operation of online Stack Emission Monitoring System;
- 8 That, the unit shall submit Environmental Statement by September every year;
- 9 That, tree plantation shall be done in space available in the complex;
- 10. That, the occupier/operator shall comply all the conditions as imposed in the Authorisation under the Bio-medical Waste Management Rules, 2016;
- 11. That, the unit shall submit Annual Report in Form –IV under the Bio-Medical Waste Management Rules, 2016 to the Board within 30th June every year;
- 12. The unit shall comply with all above conditions and submit compliance report every year to the Board.
